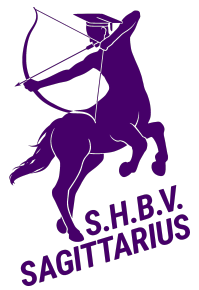

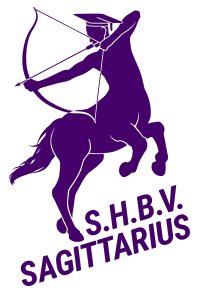

## Privacy Statement



There are various purposes for which S.H.B.V. Sagittarius collects and processes your personal data. In the context of services and agreements, we process your data for the following reasons:

### ***Purposes:***

Membership Agreement	The data as referenced before are being processed for the execution of the agreement as member of the association and as member of the Royal Dutch Archery Federation (RDAF)
Communication	Telephone number(s) and email address will be used for direct communication between the association and members

### ***Participating in matches of S.H.B.V. Sagittarius***

If you participate in matches of S.H.B.V. Sagittarius, then we register the needed personal data for the execution of the match.

Date of birth

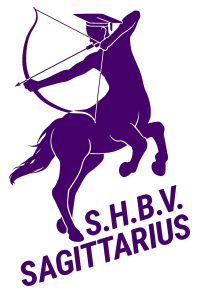
### ***Member of the Royal Dutch Archery Federation***

If you are a member of S.H.B.V. Sagittarius you are in accordance to the association statutes automatically a member of the Royal Dutch Archery Federation (RDAF). The RDAF has for the execution of the membership agreement a couple of necessary personal data, such as name, address, date of birth, and email address.

## Privacy Statement



### *Contact after membership*

If permission was given we store your full name and email address for a period up to 25 years after your membership for the sole purpose of contacting you after membership for Lustrums and other activities that involve old members. It is at all times possible to retract this permission.

### *Minors*

We only process the personal data of minors (people younger than 16 years old) if we got written permission from the parent, caretaker or legal representative of the minor.

### *Retention Period*

S.H.B.V. Sagittarius storage personal data no longer than necessary for the purpose for which they were provided or required by law. Personal data (that fall outside of statutory retention periods and other retention periods mentioned in this privacy statement) will be deleted 2 years after the termination of membership. Personal data that have a historical value/purpose to the association, such as Association records, archives, etc., will be kept in a minimised manner.

### *Security*

S.H.B.V. Sagittarius has taken the fitting technological and organisational measures to protect the personal data against unlawful processing. The following measures have been taken:

All persons who can access your data on behalf of the association are obliged to maintain their confidentiality.

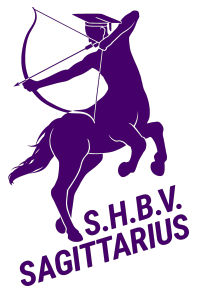
We use a username and password policy on all of our platforms

## Privacy Statement



### *Access, change, and deletion of personal data*

You have the right to inspect, rectify or delete the personal data we have of you. You can also object to the processing of your personal data (or part thereof) by us or by one of our processors. You also have the right to have us transfer the data you provide to yourself or directly to another party if desired. We may ask you to identify yourself before we can respond to the aforementioned requests.

An objection or request for deletion of personal data will be assessed on the basis of the reason for processing. Any consequences of removal, including possible termination of membership or denial of competition participation, will be communicated prior to removal.
